



# GENERAL TERMS & CONDITIONS

## MALLORCA BEACH REIS

**25 APRIL - 3 MAY 2026**

**Lindobeach and BVV Beach Life**, hereinafter referred to as "the organisation", are responsible for organising this beach volleyball trip. These general terms and conditions apply to all participants who register for the Lindobeach beach trip to Mallorca.

### **Registrations & Payment**

The agreement is established once the participant registers via the website and the payment has been received. By registering for this trip, you declare that:

- You understand that the organisation only provides the sports programme
- You agree to the payment obligation
- You acknowledge that the organisation is not liable for loss, theft or damage of personal belongings
- You acknowledge that the organisation is not liable for personal injury sustained during the beach volleyball trip
- You participate in the trip at your own risk
- You pay a fixed administration fee of €15.00 upon registration

### **Payment Method**

Payment is processed via the ClubCollect registration page.

### **Cancellation**

If you cancel the trip after registering via the website, you remain obliged to pay the full travel fee to the organisation. If you cancel the beach volleyball sports package, you must cancel your own flights and accommodation. The organisation holds no responsibility for these bookings, and no costs can be claimed from the organisation.

If the travel advisory colour code for Mallorca changes to orange or red, you may cancel free of charge. The €15 administration fee is non-refundable. Costs for flights and accommodation must be settled with your airline and accommodation provider.

If there are insufficient registrations, the organisation reserves the right to cancel the trip. In this case, the sports package fee will be refunded (excluding administration fees). Cancellation will be communicated at least one month before the start of the beach camp.

### **Documentation & Insurance**

The organisation does not offer travel insurance. Participants must arrange this themselves. Participants are responsible for having valid travel documents such as a passport and any required visa. Participants are also responsible for being informed of current requirements and regulations in the destination country.

### **Programme & Levels**

Trainers will assign groups on location in the way they deem most suitable. The organisation reserves the right to adjust the programme or training schedule if necessary. Changes do not entitle participants to a refund, unless the change significantly reduces the sports package (e.g., fewer training sessions than promised). Such cases will be handled individually.

### **Privacy Policy**

All personal data is handled confidentially and will not be shared with third parties.

### **Use of Photos & Videos**

Photos and videos may be taken during the trip for promotional purposes. By participating, you consent to the use of this material (website, social media, print). If you object, you must notify the organisation in writing before the trip begins.



# GENERAL TERMS & CONDITIONS

## **Participant Responsibilities**

Participants must follow the programme, the instructions of coaches/trainers, and the house rules and safety guidelines of the location. Failure to comply may result in exclusion from participation, without the right to a refund.

## **Liability**

The organisation is not liable for damage, loss or injury of any kind, unless caused by intent or gross negligence. Liability is at all times limited to the amount paid by the participant for the sports package.

## **Complaints**

During the trip, representatives of the organisation will be present. Any complaints must be reported immediately so action can be taken. Complaints not resolved during the trip must be submitted in writing within 14 days after the trip.

Dutch law applies to this agreement. Disputes will be submitted to the competent court in The Hague.
